1. Apologies for absence

3. Police Report by Acting Inspector John Freer

Crime: John stated that there had been a 14-15% drop in crimes over last year which amounted to about 850 less crimes.

John assisted by PC Amanda Hanusck-Moor then gave a presentation about drugs and other illegal substances. This was very comprehensive and included showing examples of the various drugs and paraphernalia. Hand-outs were given to those present. The source of this information is the 'Talk to Frank' website: http://www.talktofrank.com/. Anyone seeking a wider awareness of the drug scene is recommended to visit this website. Greater knowledge will help all of us to recognise possible use by people we know and also to be able to report suspicions of cannabis production and any drug dealing. Suspicious meetings in lay-byes for example can mean drug dealing is in progress and should be reported.

7. Existing and New Schemes

TO reported: No more new schemes have been set up by me since the last committee meeting.

However all roads in Burn Bridge now have an established scheme, although Burn Bridge Oval and Burn Bridge Road are only partly covered. Burn Bridge Road is covered from 1 – 19: there are a further 15 houses not currently in an NHW scheme.

At the request of some co-ordinators, and the agreement of all, I have now compiled a list of every co-ordinator in the area and distributed it amongst them.

After the burglary in Burn Bridge Road I spoke to a resident who informed me of previous burglaries, plus the fact that there is at least one vulnerable person living alone there. For that reason I asked Sgt Bob Chambers if an NHW scheme could be set up there ASAP: he passed this request on to PCSO Natalie Bridson for action. Currently – 2 weeks after this request – I have still not heard anything regarding any set up meeting being arranged for the near future for the Burn Bridge Road residents.

I was told a month ago that the letter-drop for Stone Rings Close was imminent, but I do not think this has happened yet!

Russell Street scheme - requested last September by a resident - has still not been set up.

I have not heard any more about a scheme being set up in Gladstone Street either – again this was requested by a resident.

8. Attendance at Events

- **8.1** Oatlands & Bilton Galas- decided we should not attend these. The general opinion was that we get little from these events.
- **8.2** My Neighbourhood Event at Ripon Police Museum 23rd March. MA offered to help set up at 10am. TO & CO to attend later.

9. SmartWater

CO reported that since our last meeting (Jan 2013) we have had orders for 16 units; twice as many as our usual average of 2 per month. Approximately half were from set-ups within the last 6 months.

10. Publicity

10.1 Newsletter – LOOK OUT

PD gave the following timetable for the issue of the April 2013 edition: Items to PD 9th April; enveloping 23rd April.

MA reminded the meeting of her suggestion to include an advert in LookOut stating the one-off cost for SmartWater.

MA said she had delivered copies of the January Look Out to Knaresborough, Bilton, Starbeck and Harrogate libraries.

- **11.1** Letter Box Stickers. These stickers were originally provided by NYP but not anymore. Following a recent request it was found that there is a wide demand for them. TO has followed this up and is exploring ways of finding a supplier.
- 11.2 NCCZ's. Funding for new schemes has run out. However the new leaflet is available for use by all members and it is now in double sided format. It supersedes the old leaflet as it now carries legal backing.
